An Act to amend the Madhya Pradesh Ayurvedic Vishwavidyalaya Adhiniyam, 2011.

Be it enacted by the Madhya Pradesh Legislature in the Seventy-fourth year of the Republic of India as follows:—

1. This Act may be called the Madhya Pradesh Ayurvedic Vishwavidyalaya (Sanskodhan) Short title. Adhiniyam, 2023.

2. For sub-section (1) of Section 12 of the Madhya Pradesh Ayurvedic Vishwavidyalaya Adhiniyam, 2011 (No. 19 of 2011) (hereinafter referred to as the principal Act), the following sub-section shall be substituted, namely:—

Amendment of
Section 12.

'(1) The Vice-Chancellor shall be appointed by the Chancellor from a panel of not less than three persons recommended by the committee constituted under sub-section (2) or sub-section (6). A person possessing the highest level of competence, integrity, moral and institutional commitment shall be appointed as Vice-Chancellor. The person so appointed as Vice-Chancellor shall have at least 10 years experience as a Professor in a Government College or University or shall be a distinguished academician with 10 years of experience and demonstrated academic leadership in a reputed Government research or academic administrative organization at the national level:

Provided that if the person or persons approved by the Chancellor out of those recommended by the committee are not willing to accept the appointment, the Chancellor may call for fresh recommendations from such committee:

Provided further that the first Vice-Chancellor shall be appointed by the Chancellor in consultation with the State Government:

Provided also that no person who has attained the age of sixty-six years shall be eligible for appointment or reappointment as Vice-Chancellor."

Amendment of
Section 17.

3. For sub-section (2) of Section 17 of the principal Act, the following sub-section shall be substituted, namely:—

"(2) The Registrar shall be appointed by the State Government on deputation from amongst such teachers with a minimum of 5 years of experience on the post of Professor of Government College or Universities or from among such officers serving under the State Government with at least 5 years' of experience at the level of Deputy Secretary or its equivalent."

Amendment of
Section 19.

4. For sub-section (1) of Section 19 of the principal Act, the following sub-section shall be substituted, namely:—

"(1) The Controller of Examinations shall be appointed on deputation by the State Government from amongst such teachers of Government Colleges or Universities with a minimum of 3 years of experience on the post of Professor or such officers of the State Government with a minimum of 3 years' of experience at the level of Deputy Secretary or its equivalent."
