“In pursuance of rule-6 read with rule 23 of the “Odisha State Prosecution Service Rules, 1997”, Government have been pleased to prescribe new Scheme of Examination and Syllabus for Competitive Examinations to be conducted by the Odisha Public Service Commission for recruitment to the posts of Cadre Assistant Public Prosecutor in Group ‘B’, Cadre Additional Public Prosecutor in Group ‘A’ & Cadre Public Prosecutor in Group ‘A’ services by amending the present syllabus as prescribed in the Home Department Notification No.11512/PGC, dated the 27th February 1999, No.49798/Pros, dated the 26th December 2012 and No.37303/Pros dated 6th November, 2015.

**SCHEME OF EXAMINATION AND SYLLABUS FOR THE POSTS OF

A. SCHEME OF THE EXAMINATION:

The Competitive Examination will consist of two stages as follows:

SCHEME OF EXAMINATION AND SYLLABUS FOR THE POST OF ADDITIONAL PUBLIC PROSECUTORS AND PUBLIC PROSECUTORS

A. SCHEME OF EXAMINATION:

1. The Competitive Examination consists of a Written Examination and Personality Test or Interview;
2. The Written examination will carry 600 Marks and Personality Test or Interview will carry 50 Marks. **Total 650 Marks;**
3. The Written Examination will be conducted in 4(Four) Papers each carrying 150 Marks. (Total 600 Marks);
4. The paper will be Subjective and Descriptive Answer type;
5. Duration of the examination for each paper will be two and half hours;
6. The Commission will fix qualifying marks for each and/or aggregate of the Written examination;
7. Depending upon the marks obtained by the candidates in the Written Examination, the Commission will shortlist candidates in the ratio of 1:2 with reference to the number of vacancies in different categories to appear for the Personality test or Interview;
8. The Final Select List will be prepared based on the marks obtained by the candidates in the Written Examination and Personality Test or Interview taken together for different categories.


