I. How to use Bare Acts in AIBE ?

- ✦ It is not an open book exam but actually it is an open bare act exam, which means you cannot bring any other book in the exam hall except bare acts.
- ✦ If the content of bare act is highlighted or underlined, then such bare act is not restricted.
- ✦ But if the bare act contains the commentary or a book of an author on the subject, then such materials are prohibited.
- ✦ Similarly, if notes or pages are stuck in the bare act, then such bare act is also not allowed.
- ✦ In other words, the bare act must contain the bare legislative text.

If you want to use bare act in the AIBE Exam hall then make sure you carry a clean, exam-friendly Bare Act only —
like the lightweight, easy-to-carry AIBE Combo Bare Act Package designed specially for exam centers. Available via www.LinkingLaws.com



I. First step is to observe the range.

- ✦ Every bare act is divided in the parts/chapters & those chapters are further divided into sub-chapters/ sub - parts & then sub -chapters are further divided into sections.
- ✦ First of all you'll have to locate the particular provision, which means you will have to figure out that particular provision to which the question relates is contained in which Chapter of the Act & what is the range of that chapter.

For example - A question is asked relating to the condonation of delay in criminal proceeding. So first of all, you must know that this provision is contained in chapter 38 of the BNSS "limitation for taking cognizance of offences " which ranges from section 513 to 519.

- ✦ Therefore, you must memorise the range of sections of the Act.
- ✦ For this purpose, there are two methods-
 1. Table method or Index Method, which means directly learning the range of sections, and
 2. Bird View Method, which means memorising the range of sections through diagrammatical representation.



2. How to attend AIBE ?

- ✦ The exam will be conducted in offline mode.
- ✦ There are total 100 questions in the paper & each question carries 1 mark.
- ✦ There is no negative markings in the paper.
- ✦ There will be 4 sets in the paper.
- ✦ In the OMR Sheet, you will have to mandatorily fill the booklet set code.
- ✦ Fill the circles of the OMR sheet very carefully.
- ✦ Bring 2 copies of admit card in the paper.
- ✦ Attempt all the 100 questions.
- ✦ Bare acts without notes are allowed but in case of unavailability of bare acts without notes, bare acts with least short notes will be allowed subject to discretion of the examiner.



- ✦ Only use black/blue ball point pen to fill the OMR Sheet. Do not use pencil or ink pen to fill the OMR Sheet. Use of whitener, eraser, blade or any fluid is strictly prohibited.
- ✦ Any type of electronic device is strictly prohibited in the examination hall.
- ✦ If there is any difference or discrepancy in the english & hindi/other languages version then the English Version is given priority.
- ✦ There will be no dress code for the paper but you should dress decently.

Method to attempt the AIBE paper -

Red, Orange & Green Method

Bifurcate the MCQ questions in three categories- Red, orange & green., at the back of your question booklet~

- ✦ **Red** - the questions about which you are totally unaware or totally blank & you do not know the answer, comes under Red category.
- ✦ For example - A question is asked that 1st Amendment in the Constitution which came in year 1951 was enforced on which date & You do not know its answer then mention this question no. in the Red category.



- ✦ **Orange** - the question which creates confusion & about which you have some information but you are not 100% sure about its answer, comes under this category. This questions can be answered after searching in the bare act.
- ✦ For example - A question is asked that police custody can be allowed maximum for how many days & You have heard about it but not completely sure about it then mention this question no. in the orange category. This question can be answered after searching in the BNSS bare act.
- ✦ **Green** - the questions comes under this category about whose answer you are 100% sure. If you are completely sure about answer of any question then fill the answer directly in the OMR sheet.
- ✦ For example- A question is asked that right to education is given in which Article of the COI & you know that it is given in Article 21A of the COI, then directly fill that answer in the OMR Sheet.
- ✦ Firstly attempt all the question from 1 to 100 & if you surely know the answer of any question then fill its answer in the OMR sheet. If you are confused about any answer then mention it in the orange category question & attempt all the orange category questions only after going through 1 to 100 questions once & at last after attempting all the orange category question, attempt the red category question about which you are totally blank.
- ✦ Solving the paper through this method will help you manage your time smartly in the exam hall & help you completing your paper within the time limit of 3 hours.



3. AIBE Preparation

- ✦ AIBE (All India Bar Examination) is an entrance exam to be qualified to practice as an advocate before any Court of Law. Without qualifying this exam, one cannot practice as an advocate in the court.

- ✦ In the AIBE 18 - Approximately 50% candidates were failed.

- ✦ It is not an open book exam but actually it is an open bare act exam, which means you cannot bring any other book in the exam hall except bare acts.

- ✦ Since AIBE is the All India Bar Examination, it is conducted at India (national) level, therefore in this exam, questions from only Central Acts are asked & questions from Local or State Acts are not asked. The laws enacted by state legislature are called state act or local Acts, such Acts are applicable only to the territory of the State which has enacted it.

- ✦ The candidates are required to score atleast 45% in this exam if belongs to general or OBC category & if belongs to SC/ST category then score atleast 40% in this exam.

 - 1) Civil major laws,
 - 2) Criminal major laws,
 - 3) Civil minor laws (common, uncodified civil law, technical law)

- 2) Criminal major laws- IPC (BNS), CRPC (BNSS), IEA (BSA)~

The laws which can be skipped from the AIBE point of view are-

This Acts are lengthy/complicated & at the same time carries insignificant weightage.



Don'ts for AIBE preparation -

- 1) Avoid studying strange topics i.e. the topics or laws which you have not studied earlier
(E.g., Taxation law, Intellectual property law, Company law)
- 2) Avoid referring Author's book at this time.
- 3) Avoid making notes in this short period.
- 4) Avoid memorising sections.

Do's for AIBE preparation -

- 1) Bare Act diagnosis
(Range analysis ~ you'll have to locate the particular provision, which means you will have to figure out that particular provision to which the question relates is contained in which Chapter of the Act & what is the range of that chapter.)

For example- if any question is asked relating to the bail. So first of all, you must know that this provision is contained in chapter 35 of the BNSS "Provisions as to bail & bonds " which ranges from section 478 to 496.

- 2) Deal smartly with the previous year questions papers .
Most of the PYQs are repetitive or recurring except landmark judgements.
