Consistent with the established practice, the Bar Council of India has conducted the All India Bar Examination in accordance with the predetermined schedule ensuring its fair and transparent conduct. The All India Bar Examination-XXI (AIBE-XXI) was conducted on 07.06.2026 across 292 examination centres situated in 60 different cities of the country. Total 1,75,701 candidates appeared in the examination. Out of total 1,75,701 candidates, total 110909 male candidates, total 64784 female candidates and total 8 transgender candidates appeared in the All India Bar Exam-XXI, reflecting wide participation from aspiring advocates across the nation. The Examination was conducted smoothly and in an orderly manner, ensuring fairness, transparency and adherence to the prescribed norms.

The All India Bar Examination was conducted in the direct supervision & guidance of the Monitoring Committee of All India Bar Examination of Bar Council of India headed by Hon'ble Ms. Justice Hima Kohli, Former Judge, Supreme Court of India, Prof. (Dr.) Manoj Kumar Sinha, Vice-Chancellor, Dharmashastra National Law University, Jabalpur, Madhya Pradesh and Prof. (Dr.) Sanjeevi Shanthakumar, Director, Gujarat National Law University, Gandhinagar, Gujarat were the members of the Monitoring Committee, whereas Prof. (Dr.) R. Venkata Rao, Vice-Chancellor, India International University of Legal Education and Research (IIULER), Goa & Former Vice-Chancellor, National Law School of India University, Bengaluru and Prof. (Dr.) V.C. Vivekanandan, Vice-Chancellor, Hidayatullah National Law University (HNLU), Raipur, Chhattisgarh were special invitees to the Monitoring Committee of All India Bar Examination of Bar Council of India.

The result was directed to be calculated on the basis of 100 marks. However, Monitoring Committee, noticed that though the cut off marks for qualifying AIBE-XXI Examination was fixed at 45 for General candidate and 40 for SC/ST/PwD candidates; however, after perusal of the Questions paper & result summary, the Monitoring Committee unanimously decided to moderate the result and reduce the qualifying marks by three (3).

The Bar Council of India is going to declare the result of AIBE-XXI today. The overall pass percentage of All India Bar Examination-XXI stands at 65.92%, indicating the performance standards achieved by the candidates.

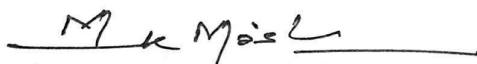
