EXAM PATTERN

KERALA

The High Court of Kerala is soon going to conduct the Kerala Judicial Service Exam 2020. This exam is conducted for the post of Munsiff - Magistrate. The selection for the said post takes place through three stages of selection. The initial stage is the preliminary exam. It is an objective type test. The candidates who clear this exam, appear for the mains exam. The mains exam consists of descriptive papers. The candidates declared successful, appear for the Viva-Voce i.e. interview. Before devising a study plan, the aspirants must be well aware of the exam pattern and syllabus for the both these examinations i.e. Prelims and Mains.


This article will cover all the details pertaining to the Kerala Judicial Services recruitment Exam Pattern along with the Syllabus. The aspirants can also download the PDF of the exam pattern and syllabus for their future reference.

PRELIMS

The preliminary exam consists of one single multiple choice type question paper. This paper consists of 3 different sections namely Part A, Part B and Part C. The total number of questions asked in this exam will be 100. Each question will carry 2 marks, making the total for maximum marks as 200. There will be a penalty of 1 mark deduction for each incorrect answer. The duration of this paper will be 2 hours 30 minutes. The qualified candidates will appear for the mains exam. The ratio of qualified students to the total number of vacancies will be 1:10.

MAINS

The main exam will be a descriptive/written exam which will include a total of four different papers. The duration of each of these papers will be 3 hours. All the papers will carry a maximum of 100 marks. The candidates equal to three times the total vacancies will be declared qualified for the viva-voce round.

Viva-voce

Only those candidates who score the prescribed percentage of marks in the main written examination shall be called for viva-voce. The viva-voce is meant to assess the candidate's General Knowledge, grasp of general principles of law, analytical ability and suitability for appointment as Munsiff-Magistrate. The cut off marks in the vivavoce is 30% for general candidates and 25% for candidates belonging to Scheduled Caste and Schedules Tribes category. Fraction of half or more or more than half shall be regarded as full marks and less than half shall be ignored. The marks secured by the candidates in the viva voce shall be added to the total marks secured by them at the written examination (Main) and the names of all those candidates shall be arranged in the respective lists on the basis of the total marks secured by them.
