No-7/Astha.-04-12/2019GAD. 186.45./In exercise of the powers conferred by Article 234 of the Constitution of India, read with the proviso to Article 309, the Governor of Bihar, after consultation with High Court of Judicature at Patna and the Bihar Public Service Commission, is pleased to make the following amendments in The Bihar Civil Service (Judicial Branch) (Recruitment) Rules, 1955:

The Bihar Civil Service (Judicial Branch) (Recruitment) (Amendment) Rules, 2023

- 1. Short title, extent and commencement:-
 - (1) These rules may be called The Bihar Civil Service (Judicial Branch) (Recruitment) (Amendment) Rules, 2023.
 - (2) It shall extend to the whole of the State of Bihar.
 - (3) After Rule 3A (i) (a) thus replaced (1) and (2) in following manner shall be deemed to have come into force with effect from the date 30.10.2019 when the vacancies were requisitioned to the Bihar Public Service Commission vide General Administration Department, Government of Bihar, letter no. 14837 dated 30.10.2019.
- 2. In the Bihar Civil Service (Judicial Branch) (Recruitment) Rules, 1955, after Rule 3A (i) (a), (1) and (2) shall be replaced by the following:-
 - (1) Ten percent of vacancies will be reserved for Economically Weaker Sections in the recruitment to the post of Civil Judge (Junior Division) which are to be filled up by direct recruitment. The aforesaid reservation will be in addition to the provisions of reservation for other categories as have been provided for in other prevailing Rules in the State of Bihar.

Provided the candidates out of the State of Bihar shall not claim for benefits of reservation under this Rule.

(2) A reserved category candidate who is selected on the basis of his merit, shall be counted against the open merit category as defined under "The Bihar reservation in vacancies in post and in services and in Admission in the Educational Institutions (For Economically Weaker Section) Act, 2019".

- 3. Repeal and Savings:-(1) Notification No.-12726 dated 30.12.2020 shall be deemed to be repealed.
 - (2) Notwithstanding such repeal under sub rule (1) of this rule anything done or any action taken according to notification No.-12726 dated 30.12.2020 shall be deemed to be legal, as if this Rules were in force on the day on which notification No.-12726 dated 30.12.2020 was in force.
