#### Paper No. 4 Law-I

#### (Substantive Law)

This paper will be of 200 marks. The question set will be restricted to the field covered by:- The law of contracts, the law of Partnership, the law concerning easements and torts, the Law relating to transfer of property including the principles of equity, specifically applicable thereto, the principal of Equity with special reference to the Law of trust and specific relief, Hindu Law and Mohammedan Law, and Constitutional Law. There shall bequestions of 50 marks in relation to Constitutional Law alone.

#### Paper No.5 Law-II

#### (Procedure and Evidence)

#### This paper will be of 200 marks.

Questions set will be restricted to the field covered by-the law of evidence, the Criminal Procedure Code and Code of Civil Procedure, including the principles of pleading. The question set will relate mainly to practical matters such as the framing of charges and issues the methods of dealing with the evidence of witnesses the writing of judgmentand the conduct of cases generally but will not be restricted to them.

#### Paper No.6 Law-III

#### (Penal, Revenue and Local Laws)

#### This paper will be of 200 marks.

Questions set will be restricted to the field covered by-

- Indian Penal Code,
- 1. U.P. Zamindari Abolition and Land reforms Act 1951,
- 2. U.P. Urban Buildings (Regulation of Letting, Rent and Eviction) Act, 1972,
- 3. U.P. Regulation of Urban Premises Tenancy Act, 2021,
- 4. U.P. Municipalities Act,
- 5. U.P. Panchayat Raj Act,
- 6. U.P. Consolidation of Holding Act, 1953,
- 7. Uttar Pradesh Urban (Planning and Development) Act 1973, together with rules framedunder the aforesaid Acts.

Answer to the questions of Local Laws will be compulsory. Questions pertaining to PenalLaw will be of 50 marks, whereas, that of Revenue and Local Laws will be of 150 marks.


