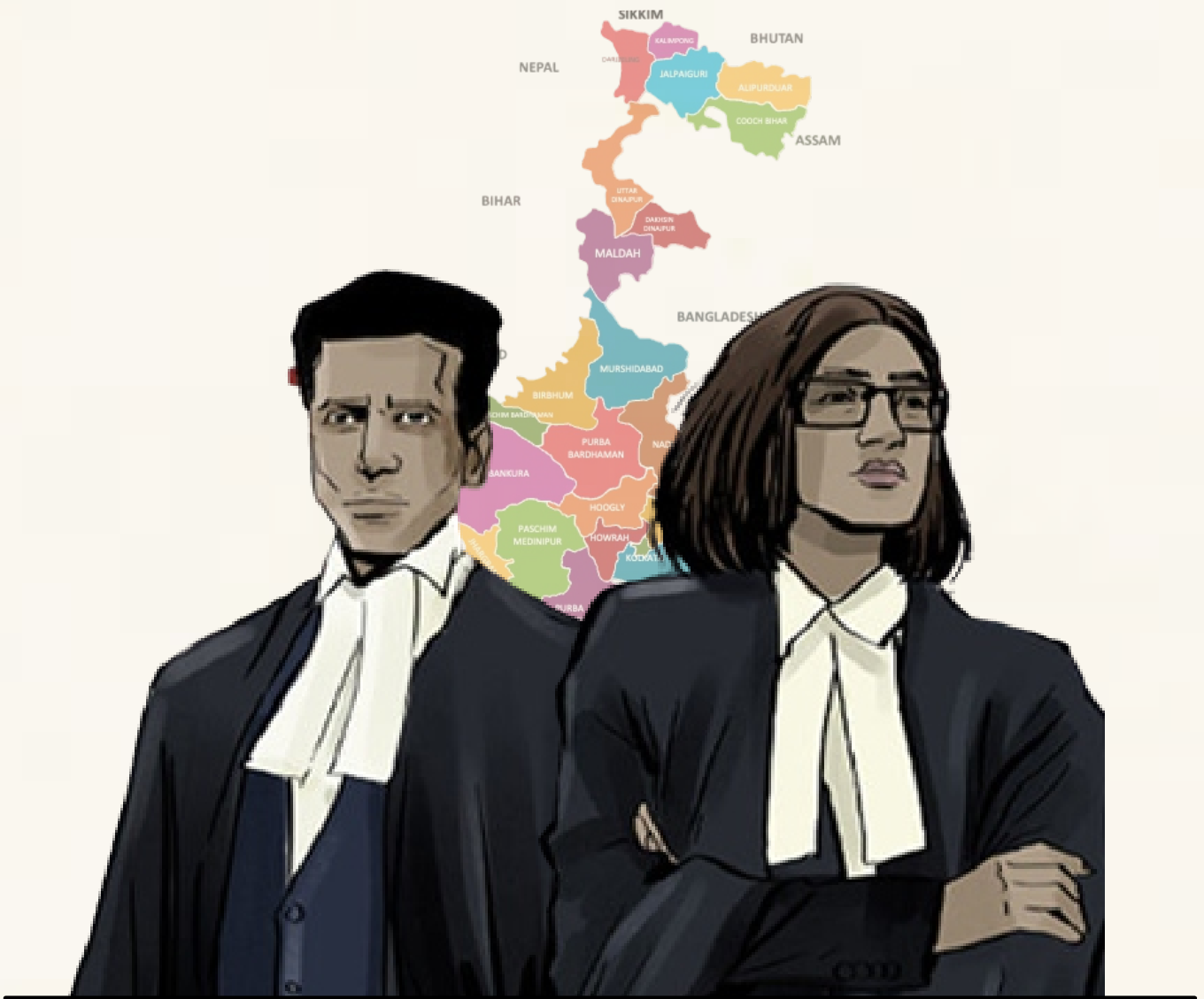

As per the **West Bengal Public Service Commission (WBPSC) – WBJs Examination 2024**, the selection process is conducted in **3 stages: Preliminary Examination → Final Written Examination → Personality Test.**

1. Preliminary Examination

5. Principles of Equity, including Law of Trusts & Specific Relief
6. Partnership Act
7. Law of Limitation & Law of Prescription
8. Indian Constitution & Constitutional Law

Each optional paper carries **100 marks** and is of **3 hours**.

3. Personality Test

Candidates qualifying in the Final Written Examination are called for the **Personality Test**.

- **Total Marks:** 100
- Conducted by WBPSC
- Final merit is prepared on the basis of **Mains + Personality Test**.

Overall Structure

Prelims → Mains → Personality Test

200 Marks → 1100 Marks → 100 Marks

→ Final Merit = Mains (1100) + Personality Test (100) = 1200 Marks
