Linked Provision- Art.19 L/w 14, 21, 358, 359 COI.

Explanation- Art.19 deals with protection of certain rights regarding freedom of speech, etc. It is the most important and key article which embodies the "basic freedoms". Art.19(1) provides that all citizens shall have the right to-

- a) freedom of speech and expression;
- b) assemble peaceably and without arms;
- c) form associations or unions;
- d) move freely throughout the territory of India;
- e) reside and settle in any part of the territory of India;
- f) Omitted by 44th amendment act. (it was right to acquire, hold and dispose of property);
- g) practice any profession, or to carry on any occupation, trade or business.

2. Which of the following Articles of the Indian Constitution gives the provision of the Post of Prime Minister in India?

Linked Provision- Art.74 L/w 75, 78, 88, 163, 164, 167 COI.

Explanation- Art.74 deals with council of Ministers to aid and advise President. It provides that there shall be a Council of Ministers with the Prime Minister at the head to aid and advise the President. Art.74(1) was substituted by 42nd Constitutional Amendment. Prior to this amendment, the President was free to make decisions based on his wisdom. He **may** also consider the Council of Ministers for their advice on the action. But, later 42nd amendment, add the phrase that the President **shall** act on the aid and advice of the council of ministers.

3. Which of the following methods is adopted for the election of the President of India?

Linked Provision- Art.54, 55 L/w 52, 53, 56-62, 77, 85-87 COI.

Explanation- Art.54 & 55 deals with election of President. Art.54 provides that president shall be elected by the members of electoral college consisting of-

- i) Elected members of both houses of parliament; and
- ii) Elected members of Legislative assemblies of state.

Further, Art.55(3) provides that the president election is held in accordance with the system of proportional representation by the means of Single Transferable Vote and the voting is by secret ballot.

4. In which of the following articles is the procedure for impeachment of the President mentioned?

(A) Article 61
(B) Article 60
(C) Article 59
(C) Article 59

Linked Provision- Art.61 L/w 52-60, 62, 77, 85-87 COI.

Explanation- Art.61 deals with council procedure for impeachment of the President. Art.56(1) proviso (b) provides that the President may, for violation of the Constitution, be removed from office by impeachment. As per Art.61, the impeachment charges can be initiated by either House of Parliament. These charges should be signed by 1/4th of members of the House, that framed the charges and a 14 days prior notice should be given to the President. The president has the right to appear and to be represented at such investigation. If the house investigating the charges, sustains the charges and passes the impeachment resolution by a majority of 2/3rd & total memberships, then the president stands removed from his office from the date on which the resolution is so passed.

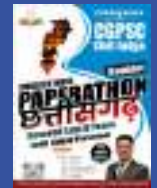
