THE BHARATIYA NAGARIK SURAKSHA SANHITA, 2023

Act No. 46 of 2023

[Enactment Date : 25th Dec. 2023]

[Enforcement Date: 01st July 2024]

An Act to consolidate and amend the law relating to Criminal Procedure.

BE it enacted by Parliament in the Seventy-fourth Year of the Republic of India as follows: —

CHAPTER I PRELIMINARY

1. Short title, extent and commencement.

- (1) This Act may be called the Bharatiya Nagarik Suraksha Sanhita, 2023.
- (2) The provisions of this Sanhita, other than those relating to Chapters IX, XI and XII thereof, shall not apply—
 - (a) to the State of Nagaland;
 - (b) to the tribal areas,
 but the concerned State Government may, by notification, apply such provisions or any of them to the whole or part of the State of Nagaland or such tribal areas, as the case may be, with such supplemental, incidental or consequential modifications, as may be specified in the notification.
- (3) It shall come into force on such date as the Central Government may, by notification in the Official Gazette, appoint.

Explanation.—In this section, "tribal areas" means the territories which immediately before the 21st day of January, 1972, were included in the tribal areas of Assam, as referred to in paragraph 20 of the Sixth Schedule to the Constitution, other than those within the local limits of the municipality of Shillong.

2. Definitions.

- (1) In this Sanhita, unless the context otherwise requires,—
 - (a) "**audio-video electronic means**" shall include use of any communication device for the purposes of video conferencing, recording of processes of identification, search and seizure or evidence, transmission of electronic communication and for such other purposes and by such other means as the State Government may, by rules provide;

 - (b) "**bail**" means release of a person accused of or suspected of commission of an offence from the custody of law upon certain conditions imposed by an officer or Court on execution by such person of a bond or a bail bond;

 - (c) "**bailable offence**" means an offence which is shown as bailable in the First Schedule, or which is made bailable by any other law for the time being in force; and "**non-bailable offence**" means any other offence;

 - (d) "**bail bond**" means an undertaking for release with surety;
 - (e) "**bond**" means a personal bond or an undertaking for release without surety;

अध्याय 1

प्रारंभिक

1. संक्षिप्त नाम, विस्तार और प्रारंभ ।

- (1) इस अधिनियम का संक्षिप्त नाम भारतीय नागरिक सुरक्षा संहिता, 2023 है ।
- (2) इस संहिता के अध्याय 9, 11 और 12 से संबंधित उपबंधों से भिन्न, उपबंध,
 - (क) नागालैंड राज्य को;
 - (ख) जनजाति क्षेत्रों को,

लागू नहीं होंगे, किंतु संबद्ध राज्य सरकार, अधिसूचना द्वारा, ऐसे उपबंधों या उनमें से किसी को, यथास्थिति, संपूर्ण नागालैंड राज्य या ऐसे जनजाति क्षेत्र या उनके किसी भाग पर, ऐसे अनुपूरक, आनुषंगिक या पारिणामिक उपान्तरों सहित, लागू कर सकेगी, जैसा अधिसूचना में विविर्दिष्ट किया जाए।

स्पष्टीकरण - इस धारा में, "जनजाति क्षेत्र" से वे राज्यक्षेत्र अभिप्रेत हैं, जो 21 जनवरी, 1972 के ठीक पहले, संविधान की छठी अनुसूची के पैरा 20 में यथानिर्दिष्ट असम के जनजाति क्षेत्रों में सम्मिलित थे और जो शिलांग नगरपालिका की स्थानीय सीमाओं के भीतर के क्षेत्रों से भिन्न हैं।

- (3) यह ऐसी तारीख से प्रवृत्त होगा, जिसे भारत सरकार, राजपत्र में अधिसूचना द्वारा, नियत करे ।

2. परिभाषाएं ।

- (1) इस संहिता में, जब तक कि संदर्भ से अन्यथा अपेक्षित न हो,
 - (क) "श्रव्य दृश्य इलैक्ट्रॉनिक" से अभिप्रेत है और इसके अंतर्गत वीडियो कांफ्रेंसिंग के प्रयोजनों के लिए, पहचान की आदेशिकाओं को अभिलिखित करना, तलाशी और अभिग्रहण या साक्ष्य, इलैक्ट्रॉनिक संसूचना का पारेषण और ऐसे अन्य प्रयोजनों के लिए किसी संसूचना युक्ति का प्रयोग और ऐसे अन्य साधन भी हैं, जिसे राज्य सरकार नियमों द्वारा उपबंधित करे :

- (ख) "जमानत" से किसी अधिकारी या न्यायालय द्वारा अधिरोपित करितपय शर्तों पर किसी अपराध के कारित किए जाने के अभियुक्त या संदिग्ध व्यक्ति द्वारा किसी बंधपत्र या जमानतपत्र के निष्पादन पर विधि की अभिरक्षा से ऐसे व्यक्ति का छोड़ा जाना अभिप्रेत है;

- (ग) "जमानतीय अपराध" से ऐसा अपराध अभिप्रेत है जो प्रथम अनुसूची में जमानतीय के रूप में दिखाया गया है या तत्समय प्रवृत्त किसी अन्य विधि द्वारा जमानतीय बनाया गया है और "अजमानतीय अपराध" से कोई अन्य अपराध अभिप्रेत है;
