



11. Facts relevant when right or custom is in question.

Where the question is as to the existence of any right or custom, the following facts are relevant—

Topic

Custom

- any transaction by which the right or custom in question was created, claimed, modified, recognised, asserted or denied, or which was inconsistent with its existence; **SEVEN THINGS**.
- particular instances in which the right or custom was claimed, recognised or exercised, or in which its exercise was disputed, asserted or departed from.






