<p><b>ORDER XIII</b> Production, Impounding and Return of Documents</p>	<ol style="list-style-type: none"><li>1. Original documents to be produced at or before the settlement of issues.</li><li>4. Endorsements on documents admitted in evidence.</li><li>8. Court may order any document to be impounded.</li></ol>
<p><b>ORDER XIV</b> settlement of issues and determination of suit on issues of law or on Issues agreed upon</p>	<ol style="list-style-type: none"><li>1. Framing of issues.</li><li>2. Court to pronounce judgment on all issues.</li><li>3. Materials from which issues may be framed.</li><li>4. Court may examine witnesses or documents before framing issues.</li><li>5. Power to amend and strike out, issues.</li></ol>
