Ans. The accused 'A' is convicted for the offence under Section 323, I.P.C.

Keeping in view the facts and circumstances of the case, age of the accused and nature of the offence and especially this fact that the accused is a first offender, I think it proper to give him benefit of probation.

Instead of sentencing the accused 'A' at once to any punishment for the offence under Section 323, I.P.C., I release him on probation, provided that the accused shall furnish a bond amounting to Rs. 2000/- with one surety of the same amount to appear and receive sentence when called upon during the period of one year, and in the meantime he shall keep the peace and be of good behaviour.
