It does not mean that the property cannot be transferred to the idol of God or temple: इसका मतलब यह नहीं है कि संपत्ति को भगवान की मूर्ति या मंदिर में स्थानांतरित नहीं किया जा सकता है:

It means that if the person transfers such property to the idol of God or temple, then it will not be governed by the provisions of this Act rather the relevant religions or charitable endowments Act will be applicable.


# To himself (स्वयं को)

The word to himself - added by the Amending Act, 1929 - in section 5.

Example → Trust (न्यास) -

where a person makes any settlement of his property in a trust & appoints himself as the sole trustee.

As trustee a person can transfer to himself.
But No person can transfer the property to him
in the same capacity.





Family Settlement / Family agreement (पारिवारिक व्यवस्था या समझौता) -

Not a transfer of property under T.P. Act .

It is informal arrangement where the members of the family agreed to divide the property among themselves. यह अनौपचारिक व्यवस्था है जहां परिवार के सदस्य

# Case: Tek Bahadur v/s Devi Singh, (1966) SC

In family settlement there is a mutual agreement between the members of the family to hold their respective chares & Separately.

It simply acknowledges defines the title of each member.






# Compromise (समझौता)



Surrender means merging of a smaller interest with a greater interest in such manner that the greater interest is not enlarged.




Example: A is landlord and B is his tenant. A as landlord has ownership of the house. Ownership or absolute interest is a larger interest.

क स्वामी है और ख किरायेदार है। क भवन का स्वामित्व रखता है। स्वामित्व अथवा पूर्ण हित दीर्घतर हित है।

B) as a tenant has also an interest in A's house but B's interest is smaller interest because it is limited only to right of enjoyment.



#### CHAPTER-II

## OF TRANSFERS OF PROPERTY BY ACT OF PARTIES / पक्षकारों के कार्य द्वारा संपत्ति- अंतरण के विषय में

- (A) Transfer of Property, whether moveable or immovable / जंगम या स्थावर संपत्ति का अंतरण
- 5. "Transfer of property" defined (" संपत्ति के अंतरण <u>की</u> परिभाषा)- In the following sections "transfer of property" means an act by which a living person conveys property, in present or in future, to one or more other living persons, or to himself, or to himself and one or more other living persons; and "to transfer property" is to perform such act.

In this section "living person" includes a company or association or body of individuals, whether incorporated or not, but nothing herein contained shall affect any law for the time being in force relating to transfer. of property to or by companies, associations or bodies of individuals.






